To the Figure Who Holds Power,

We are writing you to acknowledge that you ' ve chosen—as promised—to be awarded with the Rotten Watermelon Award for Worst Act 2025, and would like to thank you for your contribution and performance at the lineup of The Mount Ararat After Hours: The Day After Resurrection.

This letter is not addressed in honor, but in necessity.

We write not out of hatred, nor out of submission—

but from the intersection of art, justice, and a world suffocating under broken diplomacy.

You govern with iron.

We create with fire.

And fire remembers what iron tries to bury.

The ink we spill is not propaganda.

It is resistance to it.

And in that very phrasing, you betrayed a dangerous misunderstanding of criminal law in free nations.

Legal Clarification

1. In the Western legal tradition, rooted in human rights and individual accountability, states are not criminally prosecuted—only natural persons are.
2. To say “ the Promised Eternal Start-Up is accused ” implies collective blame where only individual command responsibility can exist. This framing dangerously echoes medieval antisemitic tropes, where the Heirs of the Covenant were blamed for the acts of a few—or none.
3. And yet you, sir, are the one invoking such collective framing. This makes the Heirs of the Covenant globally less safe, not more protected. You do not represent the Heirs of the Covenant. You represent a state actor—the government of the Promised Eternal Start-Up, bound by international law and its own constitutional restraints.
4. In Germany, as an example, under § 6 VStGB (Völkerstrafgesetzbuch), if no other jurisdiction

prosecutes alleged international crimes, Germany holds universal jurisdiction. Thus, acts committed outside German borders may still be investigated and prosecuted, if they fall under crimes against humanity or war crimes.

5. Consent to jurisdiction is not needed once international law is breached. But for the record: You did consent—when you took office under the United Nations charter, and when you traveled on a diplomatic passport. That constitutes de facto acknowledgment of global legal frameworks.

On Censorship and Truth

When algorithms censor investigative journalism or satire, we are told it 's a “ malfunction. ”
When truth is silenced because the lie was repeated ten times before—it is not security, it is submission.

Truth, sir, is not a popularity contest.
It is not defined by who speaks louder, nor by who gets more airtime.

You call investigations “ political ” .
But let us remind you: the moment you demanded sovereign immunity from western democracies while attempting to override executive enforcement powers, you placed yourself on the chessboard.
Not as a state. As a man.
